

## Instructions for submitting a complaint to the Attorney General.

### 1. “We the People” need to go on the record regarding what is happening in the STATE of UTAH.

Many individuals have experienced grave loss and detrimental effects of the COVID-19 measures to businesses, families, and health (physical, mental, emotional, spiritual, financial etc.) We have been restricted in so many ways that violate our unalienable rights and constitutes a trespass.

Additionally, many individuals have witnessed occurrences that do not match up with the press releases from the governor or public health officials. For example, I have heard people getting positive results for a test they never showed up for. I have also heard empty swabs being submitted and being returned with a positive result. I have heard people who work in health care claim that the ICU capacity is not full, the doctors are not burned out etc.

Because these are examples of things that I have heard they are considered “hearsay” and are *not admissible as evidence* and will not trigger investigations into fraud, malpractice or trespass.

An affidavit is your testimony of TRUTH. What you saw, or witnessed or experienced; and this is done under oath with witnesses who will witness your testimony/affidavit.

**NOW** is the time to get your truth on the record. We need to give the Attorney General, the individual appointed to oversee public safety in the STATE of UTAH, enough evidence of injury and fraud to trigger both the rescindment of COVID-19 measures and investigations into the type of technology being used to diagnose and count “cases” (the RT-PCR and antigen and antibody tests) as well as investigations into media claims that ICU’s are overflowing with patients.

### 2. Read over the affidavit.

You are the “affiant” and “affirmant” and will be affirming your truth.

Next to the bullets, write or type in different truths regarding injury or fraud that you have personally witnessed or been subjected to.

*Examples:*

*1. On July 7<sup>th</sup>, 2020, I was scheduled for a COVID test at Utah Clinic Health in Sandy UT at 9am. I slept in and missed my appointment and never submitted a swab or any kind of sample. 3 days later, I received a phone call from the clinic stating I had tested positive.*

*2. I am a respiratory technician at UUU hospital. On Oct 12<sup>th</sup>, a press release stating that our ICU unit was near capacity and that this would require certain people to be turned away or health care to be rationed due to the overwhelm. I have been working at the hospital for the weeks prior to this announcement, and while the ICU has been busy, it is typically busy and only 1/3 of patients were Covid patients.*

*3. I am a business owner of restaurant ABC. Due to COVID occupancy restrictions, I am unable to generate enough revenue and have had to let go several staff members. I have lost over 50% of my*

*business and am struggling to recover. I will likely have to close my doors and file for bankruptcy. I am depressed and in distress over this.*

*4. I have PTSD and am unable to wear a mask for extended periods. I have been turned away from several businesses who have not understood the legal exceptions and have felt immense distress over my inability to live my life in a free manner.*

*5. I have a son who committed suicide on Nov 1<sup>st</sup> 2020 due to the isolation and lack of access to his friends and sports. Our family is broken and the devastation I am experiencing is beyond comprehension. I believe the isolation drove him to take his life.*

*6. I have missed out on events (weddings, funerals, births, deaths, baptisms, church attendance, and/or graduations etc.) that are irreplaceable.*

We must get it on the record the DAMAGES the COVID-19 measures are inflicting on our lives.  
We must get it on the record any FRAUD we have witnessed or been privy to.  
We must get it on the record any INJURY or DISCRIMINATION that has resulted from COVID-19 measures.

The Attorney General has the power to stop anything that is a threat to public health and safety.

With a PEN (or type):

Fill in pages 1 & 2 with your name and testimony.

Page 3 is to NOTARIZE with a public notary and two adult witnesses.

DO NOT FILL IN THIS PAGE until you are in front of the notary. See if your notary wants witnesses present.

Once the document is filled in and signed and notarized:

1. Make a COPY.
2. KEEP the ORIGINAL.

AFFIDAVIT OF TRESPASS OR FRAUD AND DEMAND FOR INVESTIGATION AND RESCINDMENT OF  
COVID-19 MEASURES

WHEREAS; it appears there is a public health and safety threat *due to* COVID-19 measures in the STATE OF UTAH;

1. Remove the STATE of UTAH from a state of emergency and halt all mandatory and media issued testing campaigns for COVID-19 in the STATE of UTAH until a full investigation into the true reliability and validity of the RT-PCR tests and antigen tests are revealed to the people of Utah and that the results of this investigation be relayed through press releases on the Attorney General's public government website in simple to understand terms and numbers.

2. Launch an immediate and independent investigation of the ICU capacity of all of the hospitals in the STATE of UTAH and that the results of this investigation be relayed through press releases on the Attorney General's public government website through simple to understand terms and numbers.

3. As a matter of public safety, I demand that Attorney General Sean Reyes address the public about his intentions and plans to protect the people of the STATE of UTAH as well as the integrity and constitutionality of any government issued emergency and public health orders and any means used to justify or implement such orders.

Pursuant to 28 USC § 1746(1)

"...any matter is required or permitted to be supported, evidenced, established, or proved by the sworn declaration, verification, certificate, statement, oath, or affidavit, in writing of the person making the same, such matter may, with like force and effect, be supported, evidenced, established, or proved by the unsworn declaration, certificate, verification, or statement, in writing of such person which is subscribed by him, as true under penalty of perjury, and dated, in substantially the following form:"
